#### Special and / or sensitive personal data that we are processing

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children. This is to prevent data about children being collected without parental consent. #### For what purpose and on what basis we process personal data
